RE: DELINQUENT PROPERTY TAX PAYMENTS

Dear Taxpayer:

Now you may make monthly payments on your delinquent property taxes by having the payment automatically deducted from your checking or savings account.

- Your deduction will be taken from your checking or savings account on the day of your choice: either the 6th or the 20th of each month.
- Your payment would start the following month from the date you sign up.
- Participation is purely voluntary.
- If you wish to participate, you will need to complete the enclosed Automatic Deduction Authorization Form; attach a "voided" check if you are using your checking account or a deposit slip for your savings account if you are using your savings account.
- Be sure to list the TAX ID #(s) you are paying on.
- If your taxes are more than three (3) years delinquent, you must read the statements below and sign. Return this form with your Automatic Deduction Authorization Form.
- Any questions, do not hesitate to contact the Burnett County Treasurer's Office.

IF YOUR TAXES ARE MORE THAN THREE (3) YEARS DELINQUENT, YOU MUST SIGN BELOW

I understand if my taxes remain more than three (3) years delinquent, I may lose ownership of the property by tax deed action.

I understand if my mailing address changes, I must notify the Burnett County Treasurer's Office, otherwise notification of application for a tax deed normally made by certified mail will instead be made by a notice published in the Burnett County Sentinel.

I understand if I have already been notified my property is subject to a tax deed action, it is my responsibility to ensure the tax amounts being paid will pay the delinquency within the allotted time or I may lose ownership of the property. TREASURER'S OFFICE REAL ESTATE TAX PAYMENT AUTOMATIC DEDUCTION AUTHORIZATION FORM

I authorize the Burnett County Treasurer's Office to deduct a monthly Real Estate tax payment from my checking or savings account. If the payment date falls on a weekend or a holiday, the payment will be deducted on the previous business day. I understand I will need to have sufficient funds in my account to cover the payment. If funds are not available, I understand my payment/receipt will be reversed and I will be liable for charges from my bank and also the County's charge for Non-Sufficient Funds (\$30.00). Burnett County Treasurer's Office will apply my payment to the oldest tax year first. If at any time I decide to discontinue this payment service, I will notify the Treasurer's Office a minimum of one week before payment date. Payment withdrawal will start the month after this form is received by the Burnett County Treasurer's Office. There is no charge for this service; if this changes in the future, you will be notified before the change occurs and be given the choice to continue or discontinue payments.
